5.	If a player enters an offside area should the penalty awarded be a Penalty Pass/Shot?		
6.	Is a ball which hits any part of the Goalpost and rebounds into play, out of Court?		
7.	Is it true that a player who is in Court holding the ball is deemed out of Court when any object or person outside the Court is touched by that player?
